Jim Henderson asked to move the scheduled Haz Mit meeting to the August 3rd Select Board meeting. Also he noted that it should be Haz Mit not Haz Mat.

The Select Board Minutes of July 20⁶th were accepted Moved by Ed Gust 2nd by T. Santelli Select Board Orders were signed.

Mrs. Sherman gave the board a letter with her concerns about the Church's parking lot plan. She did research and does acknowledge that the Town owns the property The church will be asked to come to the next Select Board meeting to clarify the plan with a sketch of the parking site so the board and public can better understand what is being asked for.

The Town has not received any rebate for energy efficient lights put in the garage Mike will check with Hectic Electric. He noted that the monthly electric bill for the garage was \$20 less than last years with dusk to dawn lighting now in place.

The Cemetery Commission will be handling their own account. Sandy Reidy will write checks on their behalf using their work orders. NEMRC tutorial for the Towns finances continues. It will eventually make record keeping less time consuming. Tax Bills should be able to go out after the Tax Rate is set at the Aug 3rd meeting.

Rupert Road Box Culvert Grant Bids for the work were read Willy Mattison was awarded the digging. Dave Pendleton will do the cement. Mike will contact them and coordinate the work. A sign will be posted at the Rupert Rd Snow Rd Junction to let people know when the work will be done . Where the old culvert by Ron

Peros' is being replaced the Rupert Road will be closed. It will be closed for approx a week. thru traffic will be routed to the West Rd.

The Sandgate Rd pavement grinding should start Weds. July 23rd .
